 - 為全日制經評審本地學位課程非畢業年的學生或全日制經評審本地副學位課程的學生; 及
 - 能書寫暢順中文或英文和操流利粵語及英語。

申請人如具有「2016年中期人口統計調查」或其他在過去5年內由政府統計處進行的住戶統計調查的外勤工作經驗,可獲優先考慮。

網上電子習作及培訓:

初步入選的申請人將被邀請於「網上告示板」完成網上電子習作,而於網上電子習作獲得較高分數的申請人將會被邀請出席基本培訓課程。申請人出席基本培訓課程時必須攜帶學生證作審查之用。另外,申請人需要在基本培訓課程完結前作答筆試。

The Pilot Survey for the 2021 Population Census – Recruitment of Temporary Field Workers Positions

Positions:

- (1) Enumerator (about 160 positions)
- (2) Enumerator (Census Service Centre) (about 30 positions)

All of the above positions are non-civil service vacancies.

Entry Requirements:

Applicants should be permanent residents of and are lawfully employable in the Hong Kong Special Administrative Region. Applicants should possess a mature personality, be able to work independently, and fulfill the following criteria: -

- (1) Enumerator and (2) Enumerator (Census Service Centre)
 - non-final year students of local full-time accredited degree programmes; or students of local fulltime accredited sub-degree programmes; and
 - have good knowledge of written Chinese or English and be fluent in Cantonese and English.

Priority will be given to applicants possessing fieldwork experience in the 2016 Population By-census or household surveys conducted by the Census and Statistics Department in the past 5 years.

Main Duties:

(1) Enumerator

- To obtain census data through field visits; and
- To follow up on self-enumerated cases through field visits.

(2) Enumerator (Census Service Centre)

- To obtain statistical data through telephone interviews;
- To obtain census data through field visits (if required);
- To follow up on self-enumerated cases through telephone;
- To conduct verification check on completed cases through telephone; and
- To handle telephone enquiries and appointment requests.

Rest days and an alternative holiday, if applicable, will be pre-arranged within the employment period, subject to the actual circumstances such as weather conditions and work arrangements.

Job Application:

The entire application period is from 10:00 a.m. on 6 March 2020 to 6:00 p.m. on 26 March 2020.

Applicants should submit their applications via the website of the Online Job Application System for the Pilot Survey for the 2021 Population Census (https://jobs.census2021.gov.hk) within the designated application periods. All job applications will be time-stamped based on the system time of the submission. Late or incomplete applications will not be accepted. To ensure timely submission of online applications, applicants are strongly advised to complete their online application as early as possible in order to avoid any last-minute rush of applications which may overload the online system.

Online E-exercise and Training:

Shortlisted applicants will be invited to register on the Online Notice Board (ONB) and complete online e-exercises. Applicants with higher average scores on the online e-exercises will be shortlisted to attend the general training. Applicants are required to bring their student ID card to the training session for vetting. At the end of the training session, all applicants will be given a training test.

Applicants who have better performance during the training session and higher scores in the training test will be offered appointment for one of the positions.

Shortlisted applicants for the position of Enumerator or Enumerator (Census Service Centre) are required to attend a general training (8 hours) and a refresher training (8 hours) on data collection/verification duties. The training schedule is tentatively arranged as follows:

On completion of the training sessions, appointed students will receive a training allowance at an hourly rate of HK\$46.

Shortlisted applicants will normally receive a notification **by email** at least one week before the general training. Those who do not receive the notification may assume that their applications are unsuccessful.

The replacement of vacant positions arising from the withdrawal of individual Temporary Field Workers could be very difficult. **Applicants should ensure their availability during both the training and the survey operational periods.**

Training sessions may be postponed in case of severe weather or other special conditions. Applicants concerned will be notified as early as possible in case there is any change to the date/venue of training.

Applicants should attend all training sessions in order to equip themselves with the required job knowledge and skills.

Communication with Shortlisted Applicants:

All shortlisted applicants will be provided with an activation key **by email** for accessing all relevant notification messages on an Online Notice Board throughout the recruitment process. When a new message has been posted, the related applicants will receive a notification email with hyperlink to the uploaded message on the Online Notice Board. Applicants should ensure that they provide an email address that they regularly use for their job applications.

General Notes:

- (1) As an Equal Opportunities Employer, the Government is committed to eliminating discrimination in employment.
